Prior to any individual being selected for a position as a Head or Assistant Coach they must submit a completed application, agree to a background check, and be interviewed by the current Board of Directors. The information collected will only be used as the basis for review and ultimate recommendation to the LJRB President for final approval of appointment of the applicant to participate in a coaching position. We do not anticipate challenges; however, we are committed to maintaining a quality and safe environment for all participants. All results will remain confidential. Assistant coaches/instructors are selected by the Head Coach and approved by the VP of Football/VP of Cheer.

<u>Privacy Policy:</u> LJRB collects information from coaching applicants for the purposes of determining eligibility and suitability and to conduct background investigations necessary to insure the safety of our participants. We will not collect any information that is not reasonably necessary to participate in this program. Except for the information necessary to conduct background investigations, we will not disclose applicant information to any third party.

No person shall be considered for any position within the LJRB coaching staff until a completed application is submitted and approved by the LJRB President.
